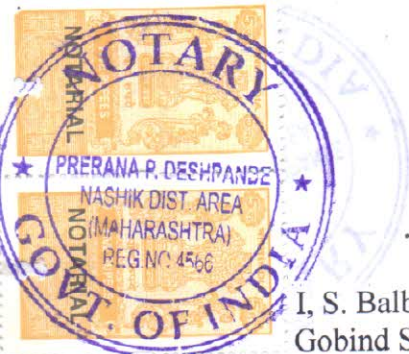

APPENDIX - I

Affidavit

I, S. Balbir Singh Chhabra, age 62 years, son of S. Balwant Singh Chhabra, Chairman of the Guru Gobind Singh Foundation, Nashik running the Guru Gobind Singh Public School & Jr. College, Nashik do hereby solemnly affirm and sincerely state as follows:

- 1) That Guru Gobind Singh Foundation Trust registered under the Society Registration on act 1860 and 1950.
- 2) That Guru Gobind Singh Foundation Trust is of Non-Proprietary character
That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner what so ever.
That no part of income from the institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person or entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.



- 5) That school is not paying any charges towards using name motto, logo or any other non-academic activities to any other institution, Organization or body.
- 6) That School will not open classes under CBSE Pattern Particularly class VIII/IX/X and will not use CBSE name in any manner without obtaining affiliation.
- 7) That the principal and correspondent/ Manager of the school have individually gone through the provisions contained in the affiliation & examination bylaws, and the circulars issued by the board from time to time. The school undertake to abide by the provisions contained in the affiliation and examination bylaws, directions issued from time to time and the law of the land.
- 8) That the school will ensure Compliance of all statutory requirements like EPF and labour laws etc. with respect to the school and staff of the school.
- 9) That the school will ensure that the Building safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- 10) That the school will ensure that all required infrastructure is available with the school before starting classes
- 11) That the school will ensure that suffice number of qualified teacher's as per the provisions Contained in affiliation bye-laws are available with the school before starting classes.
